Specifications of stoves:

- Certified Testing Report from South African Bureau Of Standards (SABS)
- Material: All stainless steel burner parts, body of galvanized steel, high quality aluminium finish.
- Number of burners: 2
- Bearing weight: Maximum 20 kg supported
- Product weight: 5.7 kg
- Fuel canister: Fuel tank empty: Full 1.79 kg
- Fuel requirements: ethanol and/or methanol fuel. Recommended water content of fuel is 10% or less
- Fuel capacity: 1.2 liters per tank
- Power on high: 1.5 kW power
- Power on low: 0.3 kW. Turn down ratio: 1/5
- Cooking time: 4.5 hours on high, up to 9 hours on low
- Average cooking capacity: 1 liter of fuel per day for family of five
- Efficiency: greater than 60%
- Emissions: Meets or exceeds World Health Organization standard for carbon monoxide emissions
